1. License. After you read and agree to this contract, pay the fee, and complete the registration form, Keyframe will allow you to host a ONE TIME public showing of the Picture, called a Screening. You may not broadcast the Picture over the internet or other medium. You may charge your audience a fee to see the Picture.

2. You AGREE AND PROMISE that that:

- a. All information provided in the registration form is complete and true.
- b. You agree to host the Screening
 - i. In a clean, friendly and safe environment,
 - ii. In a manner that does not reflect poorly on Keyframe or the Picture, and
 - iii. In compliance with all applicable laws, regulations and local ordinances.
- c. Keyframe is allowing you to Screen the Picture, and will send you a copy of the Picture. You do not own this copy of the Picture. The copy of the Picture belongs to Keyframe, and Keyframe is allowing you to use it, ONCE, to screen the Picture. If Keyframe decides that allowing you to screen the Picture would be harmful, Keyframe may cancel the Screening and revoke your rights to the Picture at any time.
- d. If your Screening gets cancelled by Keyframe, Keyframe will refund the Screening Fee, UNLESS the reason for the cancelation is due to your own actions.

3. Restrictions.

- a. This is a list of things that you CAN NOT do. This is not a complete list. For the complete list of Restrictions please check the Keyframe Terms and Conditions and Privacy Policy.
 - i. You CAN NOT modify, edit, cut, or change anything about the Picture or the Screening Kit.
 - ii. You MAY NOT remove or cover up any copyright notices or Keyframe Logo's or trademarks
 - iii. You MAY NOT put the Keyframe logo on any materials that did not directly come from Keyframe, or were authorized by Keyframe.
 - iv. You MAY NOT duplicate, sell, lend, transfer, the Picture, or make it available in any way not specifically authorized by this agreement.
- b. Thanks for being a Keyframe Screener. We enjoy having you a part of our community. However, you do not work for Keyframe. You do not speak for Keyframe. Do not in any way imply, or state that you do.
- **4. Indemnity**. Even if someone tries to sue you for something based on the Screening, or your actions in connection with the screening, You will not sue Keyframe for any damages or expenses, including attorney costs, based on this claim.
- **5. Limitation of Liability**. Keyframe will not be responsible for damages, or any kind, arising from your screening of the picture. If you ever decide to sue Keyframe for any reason related to this agreement, your damages will be limited to the licensing fee only.

- **6. Transfer.** This agreement is between YOU and Keyframe. You can not give your rights under this agreement to someone else.
- **7. Relationship.** You are not a Keyframe employee. You do not speak for Keyframe. You can not enter into other contracts on behalf of Keyframe.
